Background

Smaller community oncology practices have historically faced clinical, logistical, and economic challenges. In order to continue providing quality care for patients; these practices have had to merge with other entities and/or evolve their business models.

Dr. James Gilmore and Ray Bailey provided their insights on the value of community oncology and why consolidation has made sense for many practices.

Key Highlights

- Ancillary services provided by large oncology practices like AON or FCS—including clinical pharmacy management systems, IT infrastructure, prior authorization and financial assistance, and nurse navigator support—are key features that may not be available at smaller practices
- Community oncologists are able to leverage the full range of support and services of larger practices like AON or FCS while preserving some degree of autonomy
- Having a medically integrated pharmacy remains an important component of larger practices and offers a competitive advantage for smaller practices, which lack the infrastructure and resources

"Putting the pills in the bottle is the least important part of it. It's the clinical pharmacy patient management systems. It's the teams to help patients with financial assistance, nurses to do prior authorizations. All those things around access are incredibly important."
